**The appointment of a new Executive Director with nearly 20 years of nonprofit experience in education and social services in June 2025 marked a pivotal leadership transition that advanced the Organization's fundraising, development systems, board engagement, and governance capacity, thus positioning ShalomLearning to grow support from individual donors and foundations.** (CONTINUED ON SCH.
